RE: Updated Court Operations Notice

Greetings Colleagues:

We would again like to express our appreciation for your patience as we continue to navigate this fluid situation of providing the highest quality services to Juvenile Court families during a pandemic. The ongoing commitment of the professionals who appear in our courtrooms, as well as those who work tirelessly behind the scenes, does not go unnoticed.

The judges continue to meet regularly and discuss changes in our community as it relates to the spread of COVID-19. We also consider guidance from the Nebraska Supreme Court, the Centers for Disease Control and Protection, and our local health department. Due to the current situation as it relates to vaccines, risk assessment, and continued spread, we remind those appearing in our courtrooms that our *Updated Court Operations Notice, issued on May 14, 2021, remains in full force and effect.*

Use of Masks: We will continue to require individuals who are not fully vaccinated to wear masks when entering the Juvenile Court lobby. It is also recommended that those who are fully vaccinated wear masks when unable to socially distance from others.

In-Person Hearings: It will remain the expectation that parties and counsel appear in person for all hearings unless permission is granted by the Court, in advance, for an individual to appear in another manner. We appreciate your cooperation in reaching out to the Court as early as possible when making this request. Any requests to appear remotely for a contested hearing, such as a trial, will need to be in writing stating the positions of all parties.

As has been the situation for over a year, we will continue to provide sanitizing stations, masks, and other supplies for those who appear in Juvenile Court. Our staff will continue their best efforts at sanitizing courtrooms as necessary in an attempt to slow the spread of this virus.
