The Nebraska Supreme Court continues to carefully monitor the evolving circumstances presented by the spread of the novel coronavirus and the COVID-19 disease. Pursuant to the authority vested in the Chief Justice of the Nebraska Supreme Court under Neb. Const. art. V, § 1 and Neb. Ct. R. § 1-1101, the following administrative order is entered for the following reasons:

WHEREAS the Nebraska Supreme Court is vested with the authority to promulgate rules governing filing of pleadings and other documents in the various courts of the State;

WHEREAS at this time approximately 74 courthouses have limited or restricted public access to the county, district, and/or separate juvenile courts of the State due to COVID-19 disease concerns, State Directed Health Measures, or other actions of local health departments;

WHEREAS the courts of the State of Nebraska are open, but the public may not be able to effectively conduct business in person at a courthouse;

WHEREAS electronic means are available for attorneys to make filings with Nebraska courts, but the technology is not yet available for self-represented litigants; and

WHEREAS an alternate electronic document delivery system during the time of COVID-19 would allow greater access to the courts by self-represented litigants,

IT IS HEREBY ORDERED, pursuant to the authority under Neb. Const. art. V, § 1 and Neb. Ct. R. § 1-1101, *Emergency document*



delivery for filing in Nebraska courts, the Nebraska Supreme Court authorizes self-represented litigants to utilize email as a method of delivering documents for filing with the courts of the State. The procedures for email document delivery are outlined in a document designated "Attachment A" and attached hereto; the specific email addresses for the courts of this state to be used to email such filings are set forth in a document designated "Attachment B" and attached hereto. The State Court Administrator shall post both documents on the Supreme Court's website and shall send the same to all Nebraska courts along with a copy of this administrative order.

As provided in Neb. Ct. R. § 1-1101(B), Nebraska attorneys are prohibited from using email as a document delivery method and shall use the E-Filing system as provided in Neb. Ct. R. § 6-401 et seq. and Neb. Ct. R. App. P. § 2-200 et seq. to accomplish filings that cannot be delivered in person, by U.S. Mail, or by facsimile.

IT IS FURTHER ORDERED that this Order does not prohibit document delivery for filing by any other method, including in-person where allowed, by U.S. Mail, or by facsimile pursuant to Neb. Ct. R. § 6-601.

This Order shall remain in effect until further order of the Court, after which time the clerks of the courts of this State shall no longer accept for filing documents delivered by email.

ATTACHMENT A

Delivering documents by email for filing in Nebraska courts

Instructions:

Due to COVID-19, and pursuant to the Order of the Nebraska Supreme Court, all Nebraska courts will be accepting documents to be filed in the courts by email from self-represented litigants. Nebraska attorneys are prohibited from using email as a document delivery method. See Neb. Ct. R. § 1-1101(B).

Please follow the instructions below when emailing documents to be filed. Your email must include the following:

1. A subject line that states: "Filing in case # _____" (include case number of your existing case, if there is an existing case).

If you do not know your case number, contact your court, or email a county court information specialist to assist you: nsc.courtinformation@nebraska.gov or (844) 704-0328 (toll-free).
2. If the filing is for a new case, a subject line that states: "Filing for new case."
3. In the email body, you must provide your contact information, including the best way to contact you if there is a problem (cell phone number, email address, etc.).
4. If you are using a PDF form from the Judicial Branch website, please follow all instructions on that form. If the form does not require your signature to be witnessed by the clerk of the court or a notary public, then you may type your name on the signature line.
5. Attach the documents you want to file to the email. The documents must be in PDF format. Make sure your documents are filled out completely, filled out in English, and the PDF is clearly readable and includes all pages of your filing.

Please do not follow up with repetitive email inquiries asking if the clerk received your email. Those may go unanswered. You will receive notice from the clerk once your email has been processed.

If your filing requires a statutory docket or filing fee, you must send that fee separately to the clerk. *Note: there is no fee for requests for a protection order.*
