

# INSTRUCTIONS FOR WAIVER OF NOTICE

The purpose of this form is to allow you, as an interested party in a guardianship and/or conservatorship case to say that you do not want to receive copies of the Annual Report, Application for Approval of Annual Report, Application for Approval of Fees, or Orders and Notices of Hearings on any of these filings.

If you change your mind and decide you want to receive these, you will need to file and comply with a Request for Notice.

1. **HEADING – (This will be the same as the heading on one of the papers from the court that you already received.)**
  - a. Choose the county in the drop down box below the first blank.
  - b. Enter the case number assigned by the clerk of the court.
  - c. Enter the name of the ward/minor ward/protected person.

- v. If this form is completed by an attorney, there is a space for the bar number and firm name.

- vi. Enter the city, state, and zip code of the interested party's address.
- vii. Enter the interested party's telephone number with area code.
- viii. Enter the email address.
