

INSTRUCTIONS FOR COMPLETING PETITION FOR JUDGMENT OF EMANCIPATION

If you are printing the Petition and handwriting the answers, you will check the first box. If you are typing in your answers, you will check the second box.

- Printing the form and handwriting the answers.
- Completing the form electronically.

HEADING:

- a. Choose the county in the drop down box below the first blank. This is where you are filing the Petition.

This must be the county in which you are living.

- b. Enter your first, middle, and last names. You are the petitioner.
- c. The clerk of the district court will give you a case number when you file the Petition. You must include the case number on any papers you file.
