

# INSTRUCTIONS FOR COMPLETING THE ORDER TO SHOW CAUSE (Enforcement of Visitation Order)

## HEADING

The heading on this pleading should be the same as the heading in the original action for divorce, legal separation, paternity, or child support. The case number will also be the same.

- Choose the county in the drop down box below the first blank.
- Enter the name of the plaintiff exactly as on the original.
- Enter the name of the defendant exactly as on the original.
- The clerk of the district court assigned a case number when the original action was filed. You must include that case number on any papers you file.

## BODY OF ORDER

In the first paragraph:

- In the first blank, enter your first, middle, and last names.
- In the second and third blanks, enter the first, middle, and last names of the custodial parent against whom you are attempting to enforce the visitation order.

- In the third blank, enter the county where the original action was filed.
- In the fourth blank, enter date when your hearing will take place.
- In the fifth blank, enter the time (hour and whether it is a.m. or p.m.) when the hearing will take place.
- In the sixth blank, enter the name of the custodial parent.

If you do not know the district courtroom number, the clerk of the district court can provide it to you. In some counties, there may be only one district courtroom, and so it may not have a number. If that is the case in your county, simply cross out this blank.
- k. In the fourth blank, enter the street address of the court.
- l. In the fifth blank, enter the city and state where the court is located.
