

**INSTRUCTIONS FOR YOUR ENFORCEMENT HEARING  
(Visitation)**

Try to arrive at your hearing at least 15 minutes before your hearing is scheduled. Once you arrive for your hearing, you should ask the clerk of the district court how to let the judge know that you are there for your contempt hearing.

When the court calls your case, you will be asked if you are ready to proceed. You must tell the court that you are ready and would like to testify. You will be asked to take the stand and the court will give you an oath to tell the truth. You are then ready to go forward with your case.

You must testify to the following:
