
## COMPLETING THE AFFIDAVIT AND APPLICATION FOR ORDER TO SHOW CAUSE (Alimony/Property Settlement)

The Order to show cause orders a hearing where the other party can testify as to why they think they should not be held in contempt for not following an order for alimony or property settlement.
