## **Executive Summary**

In April 2022, the Supreme Court's Problem-Solving Court Committee formed a work group to research, describe and recommend an alternative to the current method of using judges who volunteer, but are not required, to preside over Problem-Solving Courts. The work group formed a task force that has asked the Research and Data Division of the Administrative Office of the Courts and Probation to conduct a comprehensive needs and resource assessment of PSCs in Nebraska. This project will be completed over two phases, examining the supply and demand dynamics to ascertain the need and feasibility of expanding PSCs in Nebraska. This report provides an overview of the results from Phase 1 of the Problem-Solving Court Needs Assessment which answered seven overarching questions pertaining to the demand for Problem Solving Courts. ## **Overview of Statewide Results**

### **Felony Filings**

- The data indicate that filings between January 1, 2017 and September 1, 2022, the state of Nebraska had 68,160 felony case filings.
- District 3 and District 4 had the highest number of felony filings, accounting for 44% of all felony filings.
- Felony filings have decreased at a rate of 1.5% between calendar years 2017 and 2021.
- 38% of felony filings were related to drugs.

### **Problem Solving Court Eligibility**

- 93.5% of felonies were eligible for PSC.
- Between 2017 and 2022, class 4 felonies consistently had the highest number of PSC-eligible cases throughout the years.
- Of the felony cases that were eligible for PSC, 4.2% were admitted into an existing PSC.

### **Problem Solving Court Utilization**

- Drug felony cases made up the majority (65%) of PSC cases.
- 8% of all felony drug cases were admitted to a PSC.
- 3.5% of all felony property crime cases were admitted to a PSC.
- District 8 and District 10 had the highest PSC utilization, at about 10.5% of their felony cases.
- District 12 had the lowest PSC utilization, at 1.3% of their felony cases.
- Problem Solving Courts with the most cases were Douglas County Adult Drug Court (N=486), Central Nebraska Adult Drug Court (N=337), and Lancaster County Adult Drug Court (N=316).
- There has been a 10.25% rate of increase in Problem Solving Court utilization between 2017 and 2022.

## **PROBLEM SOLVING COURT OVERVIEW**

Nebraska's problem-solving court (PSC) program was established in 1997, and today 32 PSCs operate within the district courts, or juvenile courts, in all 12 Nebraska Judicial Districts. PSCs are intensive supervision treatment programs designed for high-risk and high-need individuals. In District Court PSCs, eligible participants have pled guilty but not been convicted to an underlying felony and voluntary completion of the PSC program is required to have the conviction set aside and the felony case dismissed, thereby avoiding a felony record and possible incarceration. The goal of PSCs is to reduce recidivism and increase community safety through a coordinated court response, utilizing early intervention, individualized treatment, close community supervision and consistent judicial oversight. Current Nebraska problem-solving court models include Adult Drug and DUI Courts, Veterans Treatment Courts, Reentry Courts, Juvenile Drug Courts, Young Adult Courts, Mental Health Courts, and Family Treatment Courts.

Problem-solving courts in Nebraska operate under a team approach where a Judge, prosecutor, defense counsel, community supervision officer, law enforcement representative, coordinator, and treatment provider(s) work together to design an individualized PSC program (e.g. Drug Court). Treatment providers range from drug and alcohol counselors to employment and housing specialists. To gain admission to a District Court PSC, the county attorney may offer the prospect of resolution of the case through PSC participation to the defendant's attorney. The defendant's application is submitted to the PSC team to determine eligibility. If the defendant is eligible, the defendant pleads guilty to the felony charge, and the defendant's bond is amended to require completion of the PSC program. Compliance with the program includes substance use treatment, alcohol/drug testing, community supervision, and interaction with a judge in non-adversarial court review hearings.

Nebraska's PSCs have had positive outcomes. According to the [Nebraska Criminal Justice Reinvestment Working Group \(NCJR\) Final Report](#), "the use of PSCs has increased 31 percent between 2014 and 2019 and compared to a similar group of individuals that did not participate in a PSC, recidivism rates are 27 percent lower." While noting PSCs have had success, the NCJR Final Report goes on to say "a lack of uniform admissions standards hinders access to PSCs. While the Nebraska Supreme Court outlines eligibility standards for each of the different types of PSC, in practice, individuals hoping to be accepted into a PSC program must, in many counties, be approved by the prosecutor." Furthermore, "there are areas in the state where access to a PSC is unavailable, due to prosecutorial discretion as well as geographic challenges. In interviews with stakeholders, it is evident that expansion of PSCs is a common agreed-upon priority, however judicial resources are often cited as a barrier." A recent internal Nebraska Problem-Solving Court Expansion Recommendation report recommended new PSCs in most of Nebraska's 12 judicial districts. To support the expansion, the report recommended the addition of problem-solving administrative staff and additional judicial officers.

## **PROJECT GOAL**

In April 2022, the Supreme Court's Problem-Solving Court Committee formed a work group to research, describe and recommend an alternative to the current method of using judges who volunteer, but are not required, to preside over problem-solving courts. The work group formed a task force charged as follows: With the guidance and assistance of the Research and Data team of the Operations Division of the Administrative Office of the Courts and Probation, research and assess the need for new and expanded problem-solving courts in Nebraska and assess the need for judicial time to preside and operate in such new or expanded problem-solving courts.

The Task Force asked the Research and Data Division of the Administrative Office of the Courts and Probation to conduct a comprehensive needs and resource assessment of PSCs in Nebraska. The Task Force is seeking guidance in identifying areas in need of PSCs, areas to expand the reach and participation in existing PSCs, and help judges who want assistance in operating existing PSCs. This research project will evaluate both the resources necessary to expand PSCs (supply) and the number and types of cases eligible for disposition by PSCs (demand). An examination of these supply and demand dynamics will ascertain the need and feasibility of expanding PSCs in Nebraska.

The prospective users of the information obtained through the study are the Judicial Resources Commission, the Supreme Court's Problem-Solving Court Committee, and the Nebraska Legislature.

## **RESEARCH QUESTIONS**

**Phase 1 – Demand:** To determine demand for PSCs, the first phase of this project will begin with a needs assessment of each judicial district. This needs assessment will focus on adult PSCs over the past five years. Demand for PSCs will be determined by analyzing data from case filing information available via the state JUSTICE and NPACS data systems.

1. Of all the felony criminal cases handled in a judicial district, how many include charges/allegations that are eligible for PSC?
2. What is the distribution of the classification, e.g., Class IV, Class IIIA, Class III, etc., of the charges/allegations that are eligible for PSC?
3. What is the distribution of the charges (burglaries, thefts, drugs, etc.) of the charges/allegations that are eligible for PSC?
4. Of the cases that are eligible, in what percentage of the cases are the defendants admitted into an existing PSC?
5. What is the distribution of the classification, e.g., Class IV, Class IIIA, Class III, etc., of the felonies which are admitted to PSCs?

6. What types of cases (burglaries, thefts, drugs, etc.) are being handled by PSCs and for each type of case what percentage does that type of case bear to the entire set of cases?

7. What current trends can be identified? For example, is the number of methamphetamine cases going through PSCs stable or increasing?

**Phase 2 – Supply:** To determine the supply of PSC resources available, the second phase of this project will survey PSC stakeholders in each judicial district. The supply of judicial resources available to PSCs will be determined by using Qualtrics to survey potential PSC judges and coordinators.

1. Do judges in each district have the judicial time and interest to oversee expanded PSCs both as to the number of participants and the types of PSCs?

2. Do prosecutors in each judicial district have the time and interest in participating in the expansion of existing PSCs and the addition of new types of PSCs?

3. Do public defenders in each judicial district have the time and interest in participating in the expansion of existing PSCs and the addition of new types of PSCs?

4. Are there enough licensed treatment providers available in each judicial district to participate in PSCs?

5. Do law enforcement officers have the time and interest in participating in expansion of existing PSCs and the addition of new types of PSCs?

## **METHODOLOGY**

The first phase of this project entailed extensive data gathering and analysis on felonies over the past five years. For Phase 1, the primary dataset was derived from a Cognos query of the Judicial User System To Improve Court Efficiency (JUSTICE) court information database. For this analysis, the team queried all adult felony cases filed in district court between January 1, 2017, and September 1, 2022. A second dataset was derived from another Cognos query using the Nebraska Probation Application for Community Safety (NPACS) probation case management database with the same dates. While the JUSTICE data offers a list of filings and possible PSC clients, the NPACS database provides case management information about PSC cases. Together, the two datasets comprised over 125,000 individual entries. Given that both databases had cases with multiple charges, they were filtered to isolate the most serious charge per case. The data was then cleaned and labeled to sort each case into one of several categories based on the most serious charge filed. These 15 categories include: Aiding / Accessory / Conspiracy, Assault / Violent Crime, Attempt of a Higher Crime, Burglary, Domestic Offense, Drugs, DUI / Traffic, Exempt Felonies, Property Crime (general), Property Crime (over \$1,500), Property Crime (under \$1,500), Resist Arrest / Public Order Violation, Robbery, Sex Offense, and Weapons Charge.

For the growth rate of PSC cases over time, the annualized change over time was calculated using the following formula:

$$\text{Percent Change} = 100 \times (\text{End Value} - \text{Start Value}) / \text{Start Value}$$

Then

$$\text{Percent Growth Rate} = \text{Percent Change} / \text{Number of Years}$$

One of the subjective aspects of this project involved determining which cases are potentially eligible for PSC. While the Research and Data team are aware PSC standards state the severity of a crime should not automatically disqualify an individual from PSC, the team also recognizes that prosecutors and judges in Nebraska have broad discretion to determine PSC eligibility on a case-by-case basis. This means that PSC eligibility varies widely, not only between court districts, but also individual PSC types. In practice, there are certain violent crimes and sexual assault felonies that are unlikely to be admitted into an existing PSC. Through judicial consultation, a list of 31 excluded felonies was developed to narrow down the number of cases that are potentially eligible for a PSC. In the data analysis, these felonies are identified as “Exempt Felonies” (See Appendix 1).

## RESULTS

To begin to understand the statewide demand of PSC, the team began by analyzing the felony criminal cases handled in Nebraska and identifying cases eligible for PSC. The data indicate that the state of Nebraska had 68,160 felony filings between January 1, 2017 and September 1, 2022. A total of N=4,408 (6.5%) are exempt felonies (see Appendix I) that would not be eligible for PSC (see Table 1 and Figure 1). When examining PSC-eligible cases by offense, felony class F4 had the highest number of eligible cases followed by F3A and F2A (see Table 2 and Figure 2). Of eligible felony cases, only 4.2% (N=2,672) utilized a PSC (see Figure 3). District 8 and District 10 had the largest percentage of eligible cases, about 10.5% each, admitted into a PSC, while District 12 had 1.3% of its cases admitted into a PSC, the smallest percentage of all 12 districts. (See Figure 4). The highest utilization of PSC was for drug cases (N=1,753; see Table 3) with the majority in Douglas County Adult Drug Court (N=486), Central Nebraska Adult Drug Court (N=337), and Lancaster County Adult Drug Court (N=316; see Figure 5). Please note, the data obtained for PSC cases by court only comes from the NPACS PSC dataset since the JUSTICE data does not currently identify the PSC associated with the case.

For a distribution of the number of felony cases admitted into a PSC by offense class statewide, see table 4 and figure 6. Further examination of the ratio of drug, property crime, and weapons cases, compared to all other felony types admitted into an existing PSC statewide (see figure 7) found that drug felony cases made up the majority (65%) of the PSC cases. Even though a little over a third of felony cases involve drug charges and drug courts are the most common type of PSC in the state, only about 8% of all drug cases were handled by an existing drug court (see Figure 8). Property crime cases are even more rarely admitted, with 3.5% of all property crime felonies being handled by a PSC (see figure 9). Exempt felonies not suited to a PSC were relatively rare overall,

representing only 6% of all felony cases. Overall, the total number of felony cases admitted into an existing PSC statewide has seen a steady year over year increase with a small dip in calendar year 2020, likely due to the coronavirus pandemic (see figure 10). Overall, PSC cases have increased at an annualized rate of 10.25% per year.

For a breakdown of the broad offense types into more granular detail for both PSC-eligible and admitted PSC cases on a statewide basis, see Appendix II and Appendix III. To reduce the length of the document, the Research and Data Team has developed a [PSC Dashboard](https://tinyurl.com/ruxv56tm) (<https://tinyurl.com/ruxv56tm>) that allows the user to view a breakdown of all felony cases by category (burglary, drugs, weapons charge, etc.) including the number of “exempt felonies” that were labeled as ineligible for PSC based on the statutes listed in Appendix I.

For a breakdown of all the district data, see Appendix VI through Appendix XVII. For each district, Figure A depicts the ratio of felony cases admitted into an existing PSC out of the entire set of eligible cases. Figures B and C provide a breakdown of all felony cases by category (burglary, drugs, weapons charge, etc.) including the number of “exempt felonies” that were labeled as ineligible for PSC based on the statutes listed in Appendix I. Figure D shows the number of cases eligible for PSC, out of all felony cases, per district. Figure E shows the total number of felony cases eligible for PSC, by year, per district. Figures F and G provide a breakdown of PSC-eligible felonies by offense class, per district. Figures H and I depict the number of felony cases admitted into an existing PSC, by offense category, per district. Figures J and K depict the number of felony cases admitted into a PSC, by offense class, per district. Figure L shows the total number of felony cases admitted into an existing PSC, by year, per district.

## **DISCUSSION**

The results of this data analysis suggest that there is significant demand for an increase in PSC utilization in Nebraska. This finding aligns with previous studies that found substantial demand for PSCs in Nebraska ([NCJR, 2022](#)). While the number of felony cases handled by PSCs in Nebraska has increased at an annualized rate of 10.25% increase per, this has not been fast enough to keep pace with demand. Of all the eligible felony cases handled by district courts statewide from 2017-2022, only 4.2% were admitted into an existing PSC. 8% of all felony drug cases and only 3.5% of all property crime cases were admitted to an existing PSC. Felony drug cases made up the majority (65%) of all PSC cases. The judicial district with the highest percentage of felony cases eligible for PSC was District 11 (94.4%) and the district with the lowest percentage of cases eligible for PSC was District 8 (88.4%). Despite having the lowest percentage of eligible cases, District 8 had the highest percentage of cases admitted into an existing PSC (10.5%). District 12 had the lowest percentage of cases in a PSC (1.3%). Just three courts, the Lancaster County, Douglas County, and Central Nebraska Drug Courts, handled 44% of all PSC cases in the state.

PSCs are designed for high-risk and high-need individuals. Ideally, some sort of risk assessment metric, such as an LS/CMI score, would be considered in determining which cases are eligible for PSC. However, most individuals involved in the criminal justice system are not administered the LS/CMI until they are already either in PSC or have been sentenced to probation. In other words,

the state does not collect risk assessment information on all individuals who have a felony charge. Thus, risk assessment data was not incorporated into this analysis. This means the results represent the entire population of felony offenders, regardless of risk level. Since risk is a key component of PSC-eligibility, omitting assessment data has the potential to overstate demand for PSCs. Furthermore, eligibility criteria vary across PSC types. For example, admission standards are different between a Reentry Court and a Veterans Treatment Court. The unique edibility criteria of individuals PSCs were not considered for this study. Thus, the results represent a broad survey of felony defendants that are eligible for a generic type of PSC, without regard to admission criteria of individual PSCs.

Another limitation has to do with the validity and reliability of PSC data in Nebraska. Neither JUSTICE nor NPACS feature a 100% accurate picture of the cases admitted into a PSC. For example, PSC cases in JUSTICE are supposed to be marked with a “P” case status. However, since the courts do not have a general court order to start PSC it leaves clerks vulnerable to data entry errors making this field a questionable indicator of all cases admitted into a PSC. To remedy this shortcoming, court data from the JUSTICE data system was cross-referenced with probation data from the NPACS data system. This combination of data sources represents the closest we can come to an accurate source of truth to assess which cases ended up in a PSC. The Research and Data division has recently embarked on a process with the Director of Problem-Solving Courts that will improve the reliability of future PSC data for cases with case management within probation. Processes will need to be established in for juvenile cases managed by the Nebraska Department of Health and Human Services.

## **CONCLUSION**

This data analysis suggests there is sufficient demand to support expanding Nebraska’s Problem-Solving Courts. Even as PSC-utilization has increased over the past five years, the overwhelming majority of PSC-eligible cases are still being handled by traditional courts. Since 2017, Nebraska has made good progress transitioning drug cases into PSCs. This progress suggests there is an opportunity to begin transitioning other types of cases, such as non-violent property crime cases, into PSCs. Expansion efforts could be focused on judicial districts, such as District 12, which have lower PSC-admission rates. Future analysis should utilize statistical models to establish the relationship between PSC participation, recidivism rates, and the demographic characteristics of participants.

We recommend further collaboration with the Task Force to model what the judicial need could look like if we redistribute cases utilizing the weighted caseload model. Currently, the weighted caseload suggests that 683 judicial minutes are spent on a PSC case per year. It is worth noting that minutes on PSC cases are not meant to be a standalone indicator of work for PSCs, because judges do not solely work on PSC cases. The initial workload study arrived at the 683 minutes per case in the context of PSC admission rates of less than 5% of all cases in 2020. Today, total PSC cases still only represent 4.2% of all eligible felony cases. A hypothetical PSC expansion effort would require modeling how felony cases from other areas would transition into PSCs, and how this would affect

judicial workloads. For example, expanding PSCs to 10% or 15% of all felony cases would cause a significant shift in caseloads for judges. While the hours spent on traditional court cases would decrease, those judicial resources would be transitioned to PSC cases, theoretically increasing judicial caseloads, since PSC cases carry the heaviest weight.

Whichever policy course is chosen, we recommend closely tracking the data and following the recommendations of the National Center for State Courts which suggest that a new time-study is conducted every 6-8 years or 1-3 years after a substantial change. Increasing PSC cases from 4.2% to 10% of all felony cases may be considered a substantial change. Statistical modeling of judicial resources is not the only thing necessary to predict the effects of expanding PSCs, since the judge is not the only person on the PSC team. In addition to the judge, a PSC team is made up of a prosecutor, defense counsel, community supervision officer, law enforcement representative, coordinator, and treatment provider(s) who work together to design an individualized program. This report focused on PSC demand. It is the first phase of a two-phase PSC data collection project. The next phase will determine the supply of PSC resources available by surveying potential PSC judges, coordinators, and other stakeholders in each judicial district.

### Felony Cases in All Districts (2017-2022)



### PSC-Eligible Cases in All Districts by Class (2017-2022)



PSC Status of Felony Cases in All Districts (2017-2022)



Court Cases by Case Status





### PSC Felony Cases by Class in All Districts (2017-2022)



PSC Felony Cases by Type (2017-2022)





Felony Drug Cases (2017-22)



## **Appendix IV. Types of Problem-Solving Court**

**Adult Drug Treatment Court** was the first PSC established in Nebraska. This court admits participants who are nonviolent, have substance abuse issues, and are in need of judicial intervention to increase rehabilitation through treatment, mandatory drug testing, community supervision, and sanctions when appropriate.

**DUI Treatment Court** follows the drug court model with impaired drivers. Treatment and other court-mandated requirements are verified through non-adversarial court review hearings, frequent alcohol/drug testing, community supervision, and field and home visits.

**Family Treatment Court** is a juvenile or family court whose purview is limited to abuse, neglect, and dependency cases when parental substance abuse is the primary factor in the underlying charge. Judges, child protection services providers, and others collaborate to provide safe homes for children while the children's parents receive treatment and services to become drug- and alcohol-free.

**Reentry Court** offers programs designed to assist participants' transition back into the community after incarceration. As do other problem-solving courts, Reentry Court uses a collaborative, team-based approach to provide participants treatment and programming to affect a successful transition back in the community.


**Juvenile Drug Treatment Court** is a specialized docket within a juvenile court. Court participants with drug or alcohol problems are referred by a judge. Participants typically receive educational and family support, intensive supervision, and mental or behavioral health treatment. The Juvenile Drug Court conducts regular status hearings with the participants and collaborative treatment team.

**Young Adult Court** is a sentencing alternative for offenders up to age 26 who have been charged with a felony offense. Generally, the young adult program is an 18- to 24-month program, similar to programs offered by the Juvenile Drug Treatment Court. The program provides educational and family support, intensive supervision, and mental or behavioral health treatment, if applicable.

**Veterans Treatment Court** is one of Nebraska's newest problem-solving courts. This court is an 18- to 24-month intervention program, which provides intensive supervision and treatment to military veterans. Like other problem-solving courts, the Veterans Treatment Court uses a team-based approach, by which a judge, Veterans Health Administration representative, and others, create and implement individual programs for each participant. Compliance with the treatment program is verified through court review hearings, community-based supervision, and drug and alcohol testing.




**1A. PSC Status of all District 1 Felony Cases (2017-2022)**







### 1D. Felony Cases in District 1 (2017-2022)




### 1E. Percent of Felony Cases Eligible for PSC (District 1)







### 1K. District 1 PSC Felony Cases by Class (2018-2022)




### 1L. Total Annual District 1 PSC Felony Cases




2L. Total Annual District 2 PSC Felony Cases









### 3D. Felony Cases in District 3 (2017-2022)





### 3K. District 3 PSC Felony Cases by Class (2018-2022)




### 3L. Total Annual District 3 PSC Felony Cases








4L. Total Annual District 4 PSC Felony Cases





5K. District 5 PSC Felony Cases by Class (2018-2022)




5L. Total Annual District 5 PSC Felony Cases





6K. District 6 PSC Felony Cases by Class (2018-2022)






7L. Total Annual District 7 PSC Felony Cases








9L. Total Annual District 9 PSC Felony Cases







### 11K. District 11 PSC Felony Cases by Class (2018-2022)




### 11L. Total Annual District 11 PSC Felony Cases









### 12D. Felony Cases in District 12 (2017-2022)








