### Juvenile Community-Based Intervention (JCBI)

#### High/High Moderate Risk Juveniles

JCBI is intended for those juveniles who score at High/High Moderate risk and are in need of higher intervention. JCBI is most successful when it combines intensive case management techniques with treatment.

#### Juvenile Description and Assessment Scoring:

- 1) Considered high risk and in need of intervention by YLS/CMI.
  - **Score of 16 or above on the YLS/CMI**
- 2) Considered appropriate for JCBI when seriousness of offenses requires intensive supervision and case management.
  - **Score of 15 or below**
- 3) Has failed previously at a lower level of community supervision but is considered appropriate as an alternative to revocation or out of home care.
  - **Score of 15 or below**

#### In addition to conditions ordered by the court, the juvenile will be supervised through a combination of:

- Enhance Family engagement/team meetings
- Specialized coordinated Case management
- Cognitive restructuring and group facilitation
- Engagement with Provider/School in the field
- Home Visits

#### For added community safety, consider electronic monitoring as a tool when one or more of the following is evident:
