Service Description	An Initial Diagnostic Interview (Medication Prescriber Only) consists of an evaluation by a prescriber to determine an individual's need for psychotherapeutic medication, to provide prescription(s) as appropriate and		
	determine the plan to monitor those medications through ongoing Medication Management (as needed).		
Service Expectations	<ul> <li>This service will include the following:</li> <li>Medical evaluation of the individual's need for pharmacological intervention to address psychiatric/mental health symptoms.</li> <li>Identification of psychotherapeutic medication(s) that will help stabilize an individual's behavioral health symptoms.</li> <li>Prescription of medications will include consideration of allergies, substance use, current medications, medical history, physical status and other pertinent information.</li> <li>Plans for routine monitoring of the medication's effectiveness and side effects, including lab work (if required).</li> <li>Inform the individual about prescribed medication and side effects so s/he can effectively participate in decisions concerning treatment</li> </ul>		
	<ul> <li>decisions concerning treatment.</li> <li>If clinically necessary, the practitioner (upon permission from the individual) shall communicate with current/former providers, as appropriate, to coordinate services.</li> <li>Services must be trauma informed, culturally sensitive, age and developmentally appropriate and incorporate evidence-based practices when appropriate.</li> </ul>
