Category	Non-Treatment
Setting	Community-Based
Facility License	<ul> <li>Facility licensure is not required.</li> <li>Services must be conducted by trained mediators/facilitators associated with an approved mediation center, see Nebraska Revised Statute 43-247.03</li> </ul>
Service Description	Mediation is a problem-solving process to resolve conflict and reach an agreement between the individual, their family and other parties. Mediation is utilized when conflict in the individual's behavior increases the risk of further law violations and/or out-of-home placements. This may include restitution agreements between the individual and victim.
Service Expectations	<ul> <li>The mediation center will work with the individual, family, and other parties to come to resolution on questions of restitution as a result of a legal charge or resolve a particular issue of conflict referred by the probation/problem solving court officer.</li> <li>Identify, contact and prepare relevant participants</li> <li>Identify location for mediation</li> <li>Provide written updates (i.e., session scheduled/held, who attended, if needs identified in referral were addressed) and if an agreement was reached to probation/problem solving court officer within 5 business days of the completed mediation/restorative conference. The Mediation Services Verification can be used for this update.</li> <li>Program plan required □ Yes ⊠ No</li> </ul>
Service Frequency	Frequency of services will vary based on the needs of the individual and other participants.
Length of Service	<ul> <li>Up to 5 hours per mediation/restorative conference (aka dialog, conference, circle, meeting, etc.), including individual private preparation sessions and joint meeting time.</li> <li>Multiple individual and joint sessions may be required to achieve service outcomes.</li> <li>Additional hours per mediation/restorative conference may be approved by special exception when the mediation center communicates to probation/problem solving court the extenuating circumstances requiring additional hours.</li> </ul>

Staff to Client Ratio	Staffing shall be a minimum of one facilitator/mediator.
