IVPET

Juvenile Petition

Juvenile Petition

Description: This is the action code you will use when a status or delinquency petition is filed.
See checklist "How to Add a Juvenile Case".

DETHRG

Detention Hearing

Detention Hearing

Description: This is the hearing where the youth comes before the judge for a detention hearing following probation intake. This includes a youth who was placed on electronic monitor, placed in a secure or staff-secure facility, or through probation intake was put on some other restriction of liberty. This does not include a situation where a judge detains a child at another hearing, such as a disposition hearing.

This action must be added with ADDACTS. See checklist

ODETHRG

Detention Order

Order-Detention Hearing

Description: Following the detention hearing, indicate if the judge ordered continued detention, ordered a detention alternative, released the child from detention, or otherwise modified placement.

This action must be added with ADDACTS. See checklist "How to Add a Filing to a Case".

OAPPTCNS

Appointment of Counsel

Order Appointment of Counsel

Description: This code is used if the judge appointed private counsel to represent the youth. This code is only for use when the judge appoints defense counsel for the child, not when a GAL is appointed.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

OAPPTPD

Appt of Public Defender

Order Appointment of Public Defender

Description: This code is used if the judge appointed the public defender's office to represent the youth. If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

First Appearance

Description: This is the hearing where the juvenile is advised of the allegations contained within the petition

and his/her due process rights.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

OFIRSTAP

First Appearance Order

Order First Appearance

Description: Use this action code when the judge has entered the order from the First Appearance.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

ARRAIGN

Arraignment

Arraignment (Douglas & Sarpy Only)

Description: This is the hearing where the juvenile is advised of the allegations contained within the petition and his/her due process rights.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

OARRAIGN

Order- Arraignment

Arraignment Order (Douglas & Sarpy Only)

Description: Use this action code when the judge has entered the order from the Arraignment.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

MTRANICC

Motion Transfer JV to CC

Motion - Transfer Juvenile to County Court

Description: Use this action code when there is either a document filed or there is a motion made in court for the Juvenile case to be transferred to County Court criminal. This action must be added with ADDACTS. See checklist "How to Add a Filing to a Case".

TRANICC

Transfer JV to CC

Transfer Juvenile to County Court

Description: This code will populate automatically when using TRANCASE to transfer the Juvenile case to County Court. This action code is non-enterable from ADDACTS

MTRANJDC

Motion-Transfer Juvenile to District Court

Motion Transfer IV to DC

Description: Use this action code when there is either a document filed or there is a motion made in court for the Juvenile case to be transferred to District Court criminal. This action must be added with ADDACTS. See checklist

"How to Add a Filing to a Case".

TRANJDC

Transfer Juvenile to District Court

Transfer JV to DC

Description: This code will populate automatically when using TRANCASE to transfer the Juvenile case to District Court. This action is non-enterable from ADDACTS.

MTRANAJV

Motion-Transfer Adult Court to Juvenile

Motion Transfer Adult to JV Description: Use this action code when there is either a document filed or there is a motion made in court for the Adult case in either County Court or District Court to be

transferred to the Juvenile court.

This action must be added with ADDACTS. See checklist

"How to Add a Filing to a Case".

TRANAIV

Transfer Adult Court to Juvenile

Transfer Adult to IV

Description: This code will populate automatically when using TRANCASE to transfer the case from either County Court or District Court to Juvenile court. This action is

non-enterable from ADDACTS.

ADJUDICATION

ADJUD-

Adjudication Hearing

Adjudication

Description: This is the hearing where the court determines whether the juvenile comes within the meaning of 43-247. This may be a formal trial, or the juvenile may admit to part or all of the allegations. If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

OADIUD

Adjudication Hearing Order

Order-Adjudication

Description: This is used following the adjudication and indicates whether the decision was that the child fell within the meaning of Neb. Rev. Stat. 43-247 or if the judge dismissed the case.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

ADMIS-Admission

Juvenile admits the allegations in the petition

Description- This entry should be made when the juvenile admitted to part or all of the allegations in the petition, thus preventing the need for a formal trial.

This action must be added with ADDACTS. See checklist "How to Add a Filing to a Case".

EVALORD

Evaluation Ordered

Evaluation Ordered

Description: Use this action code when the judge orders an evaluation be completed for a youth. Only enter the code once per hearing, even if the judge orders multiple evaluations in one hearing.

This action must be added with ADDACTS. See checklist "How to Add a Filing to a Case".

EVALRECD

Evaluation Received

Evaluation Received

Description: Use this code when the court receives the evaluation it ordered.

This is a future action and should be completed from COMACTS. If the action is not on COMACTS, the action must be added with ADDACTS. See checklist "How to Add a Filing to a Case".

POST-ADJUDICATION DISP-

Disposition Hearing

Dispositional Hearing

Description: This is the hearing always held after the Adjudication Hearing where the judge sets the terms of probation. It may occur the same day as the Adjudication Hearing, but often times does not.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

ODISP- Order Dispositional Hearing

Disposition Hearing Order

Description: This is where the judge either orders probation or probation by the court. The judge may order the case closed after a period of time, set the matter for continued disposition or set the matter for a probation review hearing.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

MREVPROB-

M-Revoke Probation

Motion to Revoke Probation

Description: This is the code to use when the county attorney files a motion to revoke a youth's probation. This action must be added with ADDACTS. See checklist "How to Add a Filing to a Case".

VOPHRG-

Violate Prob. Hrg.

Violation of Probation Hearing

Description: Use this code to indicate when the hearing on the motion to revoke probation is before the court following the filing of a motion to revoke.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

OREVPROB-

Order Revoke Probation

Order Revoke Probation

Description: Following a hearing to revoke probation, this order indicates whether the judge revoked the minor's probation. The court will likely set the matter for a disposition hearing if the he/she finds the minor violated his/her probation.

This action must be added with ADDACTS. See checklist "How to Add a Filing to a Case".

REETNRY

Reentry Hearing

Reentry Hearing

Description: Use this code for the continued disposition hearing when a youth is returning from YRTC-Kearney or YRTC-Geneva. There may not need to be a hearing if the parties stipulate to the reentry plan.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

OREENTRY

Order Reentry Hearing

Reentry Hearing Order

Description: This order is used when the youth returns from placement at YRTC-Kearney or YRTC-Geneva. The judge may adopt the reentry plan in its entirety or modify it. Also, the judge relieves OJS/HHS in this order.

If DOCKET is being used, this action will write to UPDROA. If DOCKET is not being used, use ADDACTS to add the action. See checklist "How to Add a Filing to a Case".

COMPLETION OF PROBATION/CLOSE OF CASE & SEALING OF RECORD

SATREL- Prob.

Satisfactory Release from Probation

Satisfactory release

Description: Use this code when the youth successfully

completes probation.

This is a future action from Probation and should be completed from COMACTS. If the action is not on COMACTS, the action must be added with ADDACTS. See

checklist "How to Add a Filing to a Case".

UNSATREL- Prob. Unsatisfactory release

Unsatisfactory Release from Probation

Description: Use this code when the judge

unsatisfactorily terminates the youth's probation order

and closes the case.

This is a future action from Probation and should be completed from COMACTS. If the action is not on COMACTS, the action must be added with ADDACTS. See

checklist "How to Add a Filing to a Case".

JURSTERM-

Jurisdiction Terminated

Jurisdiction Terminated

Description: Use this code when court jurisdiction closes on the juvenile. This code changes the case status from

closed to terminated.

Please note there is a separate entry on RCDJINFO-Record

Juvenile Information Screen-Court Jurisdiction

Terminated Y/N. See checklist "How to Use RCDJINFO".

OSEAL

Order Sealing Records

Order Seal Records

Description: Following the closing of a case, use this code if the judge orders the youth's record sealed. Also, use following a motion to seal records if the judge seals the youth's record.

This action must be added with ADDACTS. See checklist

"How to Add a Filing to a Case".
