

# Canon 2: Representation of qualifications

Canon 2 of our Code of Ethics states Interpreters shall accurately and completely represent what their training and pertinent experience is and any certification they may have. I am seeing an uptick in Registered and Non-certified interpreters being listed as Certified on Journal Entries & Orders. When that happens, it causes extra work as we then have to go back and ask the Judge or Clerk Magistrate to do a Nunc Pro Tunc order to protect the integrity of the record. I don't believe that interpreters are purposely misrepresenting their qualifications but may be too timid to interrupt to clarify. However, interrupt they must – this is a non-negotiable as the reputation of the entire profession is at stake! I and the Operations Team stand ready to guide interpreters on successfully and respectfully interrupting, so please reach out to us!

# District 2 Probation moving to Bellevue

Probation and Language Access met to ensure there is no disruption of services for justice involved individuals when District 2 Probation transitions to its new Bellevue location on January 21<sup>st</sup> and 22<sup>nd</sup>. Future locations:

- Primary location at 1410 Wall Street, Bellevue, NE 68005
- Secondary location at the Sullivan building for reporting after Court

Language Access will partner with Probation to:

- Translate documents including door flyers and instructions
- Explore expanding blocks or implementing new blocks
- Explore what services could be provisioned remotely

### Tax Documents

State Accounting will mail out the 1099s by January 31st. The minimum amount an individual needs to earn to receive a 1099 is \$600. If you have questions or do not receive your 1099 by the beginning of February, you can reach State Accounting directly at (402)471-2581.
