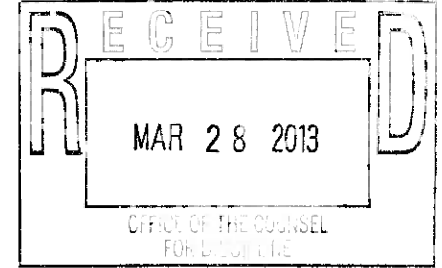

ORDER

On January 31, 2013, pursuant to an Application for Temporary Suspension made by the Chair of the District Five Committee on Inquiry, John A. Sellers, Respondent, was ordered to show cause why this court should not enter an order temporarily suspending his license to practice law in this state. No response was filed.
