Appeal dismissed for lack of jurisdiction pursuant to Neb. Ct. R. App. P. § 2-107(A)(1). The district court properly found that it lacked jurisdiction over appellant's mandamus action, as his amended complaint for mandamus was not properly verified nor supported by affidavits. See State ex rel. Malone v. Baldonado-Bellamy, 307 Neb. 549, 950 N.W.2d 81 (2020) (filing of motion and affidavit or verified petition is jurisdictional requirement before district court may issue writ of mandamus, and until such filing is made, court does not have jurisdiction over action for writ of mandamus). As a result, this court also lacks jurisdiction over this appeal. See id.
