Misc Submission to Court re Jurisdiction

Appeal dismissed for lack of jurisdiction pursuant to Neb. Ct. R. App. P. § 2-107(A)(1). Appellant's notice of appeal, filed March 20, 2025, is of no effect. Appellant filed a motion on March 21 asking the district court to alter or amend its March 14 judgment. Neb. Rev. Stat. § 25-1912(3) (Cum. Supp. 2024) provides, in relevant part, that "[t]he running of the time for filing a notice of appeal shall be terminated as to all parties by a timely motion to alter or amend a judgment under section 25-1329." There is no indication in the transcript that there has been a ruling on said motion, and therefore, there is not yet a final, appealable order. See, Crawford v. Crawford, 18 Neb. App. 890, 794 N.W.2d 198 (2011) (appeal dismissed for lack of jurisdiction because there was no final, appealable order when trial court had not yet entered order ruling on timely filed tolling motion).
