Motion of Appellant for Rehearing & Brf

Appellant's motion for rehearing overruled. Although Appellant raised the issue of trial counsel's alleged misrepresentations in his post-evidentiary hearing brief to the district court, the court did not address it, nor was it required to do so because the issue was not raised in Appellant's motion for postconviction relief. The record indicates that Appellant had knowledge of trial counsel's alleged misrepresentations well before trial counsel's postconviction deposition. Prior to filing his operative amended motion for postconviction relief, Appellant was present at the hearing on the motion for new trial during which trial counsel made an alleged misrepresentation and Appellant was also aware of trial counsel's alleged misrepresentation to the appellate court. He therefore possessed sufficient facts to raise the issue of trial counsel's alleged misrepresentations in his motion for postconviction relief and failed to do so. Appellate court will not consider issue on appeal from denial of postconviction relief that was not raised in motion for postconviction relief or passed upon by postconviction court. See State v. Stelly, 308 Neb. 636, 955 N.W.2d 729 (2021).
