Appellee's motion for summary affirmance is sustained. See Neb. Ct. R. App. P. § 2-107(B)(1). Neb. Rev. Stat. § 29-2292 (Cum. Supp. 2022) does not require entry of deferred judgment of conviction when probation is imposed; rather it is a matter of discretion by the sentencing court. See State v. Gnewuch, 316 Neb. 47, 3 N.W.3d 295 (2024). Absent abuse of discretion, a sentence will generally be upheld. See State v. Senteney, 307 Neb. 702, 950 N.W.2d 585 (2020).
