Mot. of Appellee for Summary Dismissal

Appellee's motion to summarily dismiss appeal as moot is sustained. Affidavits supplied by Appellants do not meet their burden of proof to establish that payments were not voluntary. See, Mut. of Omaha Bank v. Kassebaum, 283 Neb. 952, 814 N.W.2d 731 (2012) (when party voluntarily complies with mandate of trial court, satisfying judgment, appeal no longer presents an actual controversy, but an abstract question); D B Feedyards v. Environmental Sciences, 16 Neb. App. 516, 745 N.W.2d 593 (2008) (burden falls to appellant to demonstrate, by affidavit, that appellant's satisfaction of judgment was not voluntary, but was instead result of coercion by legal process); Ray v. Sullivan, 5 Neb. App. 942, 568 N.W.2d 267 (1997) (affidavits may be presented to appellate court, apart from trial court record, to establish whether party has dealt with judgment in a way which waives right to appellate review).
