ROD September Early Case Review

The district court's order entered on August 8, 2024, is summarily affirmed. See Neb. Ct. R. App. P. § 2-107(A)(2). Said order vacated the city council's action to limit the 12-month building permit to 3 months, thus leaving in place the 12-month permit issued by the clerk. Appellant failed to specifically argue his assigned errors. To be considered by an appellate court, the party asserting an alleged error must both specifically assign and specifically argue it in the party's initial brief. 132 Ventures v. Active Spine Physical Therapy, 318 Neb. 64, 13 N.W.3d 441 (2024).
