Appellant's request for habeas based on alleged inadequate factual basis is improper because habeas is a collateral attack on the judgment of conviction and, where the court has jurisdiction of the parties and the subject matter, its judgment is not subject to collateral attack. Sanders v. Frakes, 295 Neb. 374, 888 N.W.2d 514 (2016). See also Childs v. Frakes, 312 Neb. 925, 981 N.W.2d 598 (2022) (regularity of proceedings leading up to sentence in criminal case cannot be inquired into on petition for habeas relief).
