App. P. § 2-105(B)(2)(a) (rev. 2023) requires appellant to file a request for preparation of the bill of exceptions at the same time the notice of appeal is filed. Absent simultaneous filing, leave of court must be obtained to request the bill of exceptions out of time. Id. No leave was sought; therefore, this court does not have a bill of exceptions before it. It is an appellant's duty to include in the bill of exceptions matters which are material to the issues presented for review. In re Interest of Rondell B., 249 Neb. 928, 546 N.W.2d 801 (1996). In the absence of a complete bill of exceptions, it is presumed that an issue of fact raised by the pleadings was sustained by the evidence and that it was correctly determined. In re Estate of Weeder, 318 Neb. 393, 16 N.W.3d 137 (2025). Having reviewed the pleadings, we affirm.
