Gordon v. People of the State

ROD Misc Submission to Court re Jurisdiction

Appeal dismissed for lack of jurisdiction. See Neb. Ct. R. App. P. § 2-107(A)(1). Appellant did not timely appeal from the district court's January 27, 2025, denial of his habeas petition. Appellant's "Second Petition for Writ of Habeas Corpus, Rehearing" filed February 19, 2025, sought reconsideration of the January 27, 2025, order. A party can move the court to vacate or modify a final order, but if the court does not grant the motion, a notice of appeal must be filed within 30 days of the entry of the earlier final order if the party intends to appeal it. See e.g. Bryson L. v. Izabella L., 302 Neb. 145, 921 N.W.2d 829 (2019). When such a motion does not introduce an "intervening new matter" and instead merely contends that the initial order dismissing the case was erroneous, the appeal of an order denying that motion is untimely if not filed within 30 days of the order initially dismissing the matter. Green v. Seiffert, 304 Neb. 212, 933 N.W.2d 590 (2019).

ROD Mot. of Appellee for Summary Dismissal

Appellee's motion for summary dismissal is sustained. Appeal dismissed for lack of jurisdiction. See Neb. Ct. R. App. P. § 2-107(A)(1). Appeal is prematurely filed. The Workers' Compensation Court's award dated April 22, 2025, expressly reserved issue of the attorney fees award for further hearing on May 29, 2025. Appellant filed notice of appeal on May 15, 2025. See, State ex rel. Fick v. Miller, 252 Neb. 164, 560 N.W.2d 793 (1997); In re Trust of Lamprecht, 315 Neb. 832, 2 N.W.3d 181 (2024).
