Page: All four appeals challenge the February 11, 2025, order entered by and filed in the Separate Juvenile Court of Sarpy County. Appeals filed in A-25-176 and A-25-177 were filed within 30 days of the February 11 order. Appeals filed in A-25-337 and A-25-338 were filed within 30 days of the juvenile court's April 22 order allowing the withdrawal of appellee's motion to alter or amend judgment. Appellee's motions to summarily dismiss appeals filed in A-25-176 and A-25-337 for lack of jurisdiction are are overruled; however, the issue of jurisdiction is preserved and the parties are directed to address the following questions in the jurisdiction section of their briefs: (1) the notices of appeal filed in A-25-177 and A-25-338 identify the juvenile court in the caption but were file-stamped in the district court; does the filing of the notice of appeal in the district court rather than in the juvenile court impact this court's jurisdiction over those appeals?; (2) the notices of appeal filed in A-25-176 and A-25-337 identify the district court in the caption and were file-stamped in that court; does the appellee's pending counterclaim in the district court render any appeal from that court premature?; (3) appellee filed a motion to alter or amend judgment in the juvenile court after the juvenile court transferred jurisdiction to the district court; what, if any, impact did the motion to alter or amend have on the finality of the February 11 order?; (4) to the extent the appellee's motion to alter or amend tolled the time to appeal, did the juvenile court's April 22 order withdrawing the motion to alter or amend without dismissing it sufficiently dispose of the motion? See State v. Bao, 269 Neb. 127, 690 N.W.2d 618 (2005) (motion to alter or amend withdrawn and ordered dismissed); and (5) to the extent custody and parenting time issues remained pending in the district court, did the juvenile court's February 11 order nevertheless impact a substantial right?

Appeals filed in A-25-176 and A-25-177 were filed within 30 days of the February 11 order. Appeals filed in A-25-337 and A-25-338 were filed within 30 days of the juvenile court's April 22 order allowing the withdrawal of appellee's motion to alter or amend judgment. Appellee's motions to summarily dismiss appeals filed in A-25-176 and A-25-337 for lack of jurisdiction are are overruled; however, the issue of jurisdiction is preserved and the parties are directed to address the following questions in the jurisdiction section of their briefs: (1) the notices of appeal filed in A-25-177 and A-25-338 identify the juvenile court in the caption but were file-stamped in the district court; does the filing of the notice of appeal in the district court rather than in the juvenile court impact this court's jurisdiction over those appeals?; (2) the notices of appeal filed in A-25-176 and A-25-337 identify the district court in the caption and were file-stamped in that court; does the appellee's pending counterclaim in the district court render any appeal from that court premature?; (3) appellee filed a motion to alter or amend judgment in the juvenile court after the juvenile court transferred jurisdiction to the district court; what, if any, impact did the motion to alter or amend have on the finality of the February 11 order?; (4) to the extent the appellee's motion to alter or amend tolled the time to appeal, did the juvenile court's April 22 order withdrawing the motion to alter or amend without dismissing it sufficiently dispose of the motion? See State v. Bao, 269 Neb. 127, 690 N.W.2d 618 (2005) (motion to alter or amend withdrawn and ordered dismissed); and (5) to the extent custody and parenting time issues remained pending in the district court, did the juvenile court's February 11 order nevertheless impact a substantial right?
