Keating, O'Gara, 319 Neb. 390, 22 N.W.3d 671 (2025) (single, signed written document stating all of relief granted or denied in action is required for judgment; appellate jurisdiction cannot be created through voluntary dismissal of claim without prejudice).

Mot. of Appellee for Summary Affirmance

Motion of Appellee for summary affirmance is sustained. See Neb. Ct. R. App. P. § 2-107(B)(2). The district court took the appropriate factors into consideration when sentencing Appellant. See State v. Jones, 318 Neb. 840, 19 N.W.3d 499 (2025) (absent abuse of discretion by trial court, appellate court will not disturb sentence imposed within statutory limits). Further, substantial and compelling reasons were provided to overcome the presumption of a sentence of probation for a Class IV felony and the court adequately stated its reasoning for the sentence of incarceration in open court, on the record, as required by Neb. Rev. Stat. § 29 2204.02(3) (Reissue 2016). See State v. Baxter, 295 Neb. 496, 888 N.W.2d 726 (2017).
