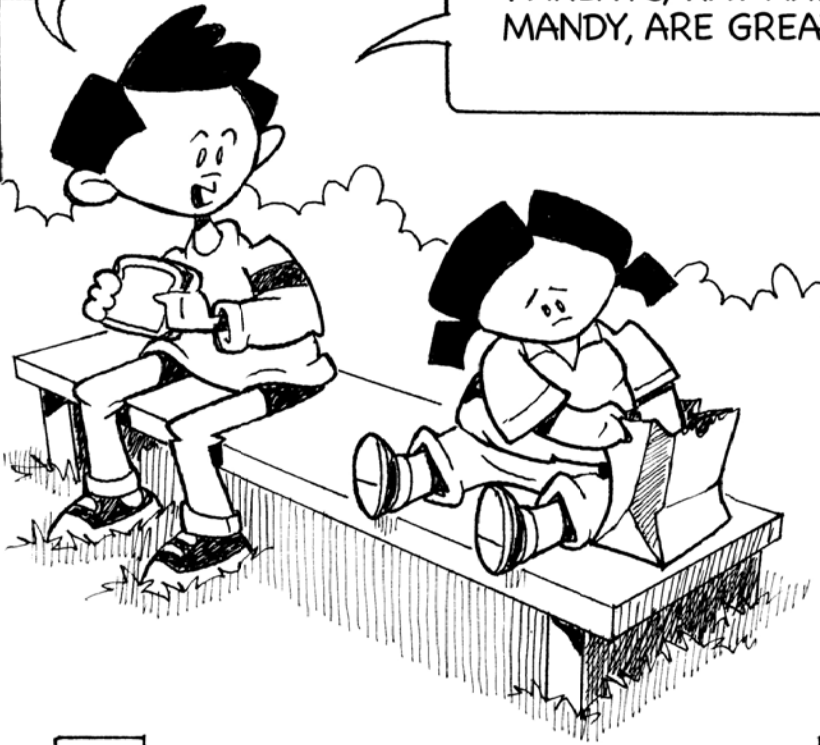

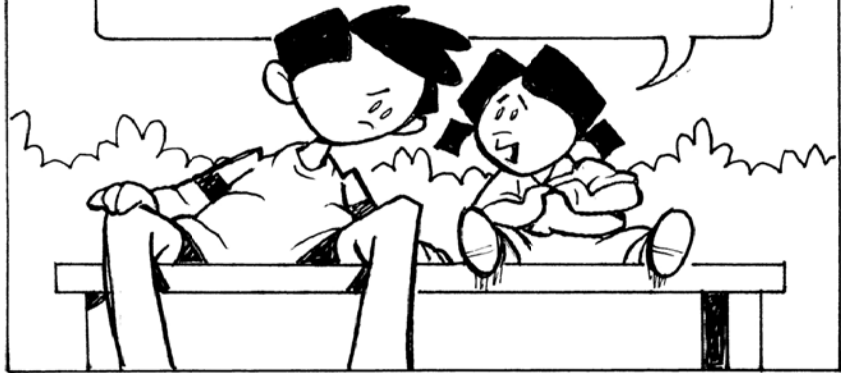

TOGETHER?



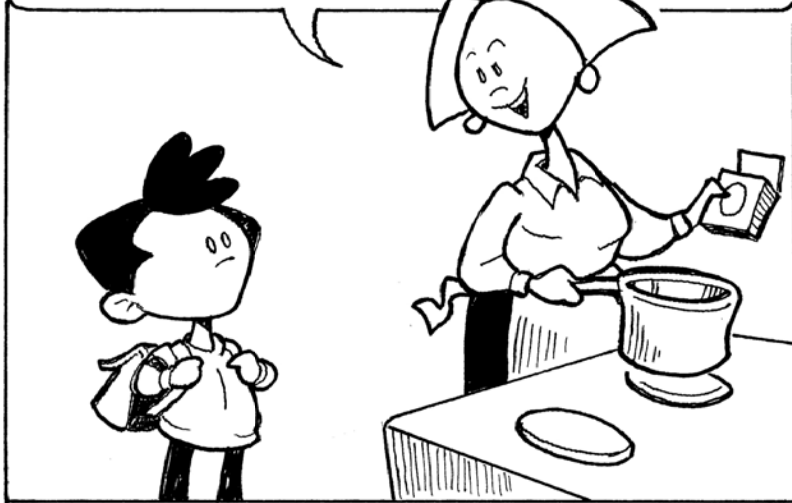
I'M SORRY, EMMA... I WISH WE

SOMEDAY SOON.



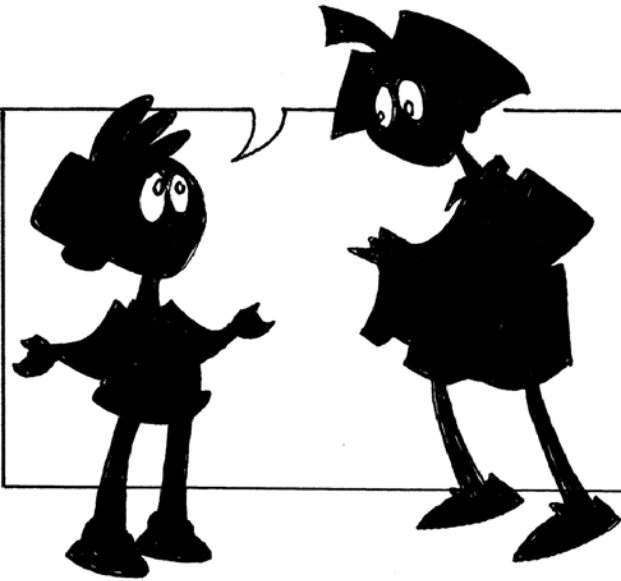
HOW WAS SCHOOL TODAY, BEN?
DID YOU GET TO SEE YOUR SISTER?



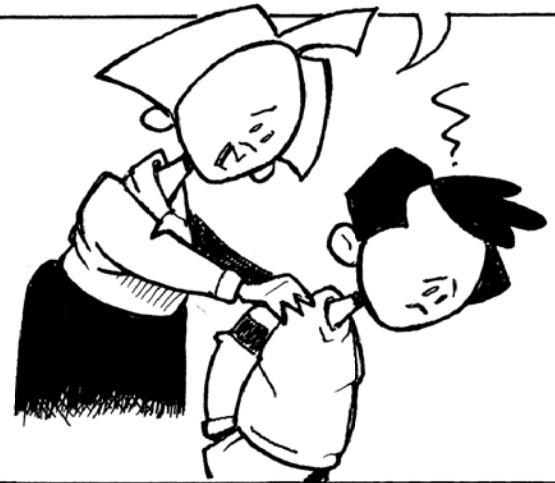
SCHOOL WAS FINE, AND

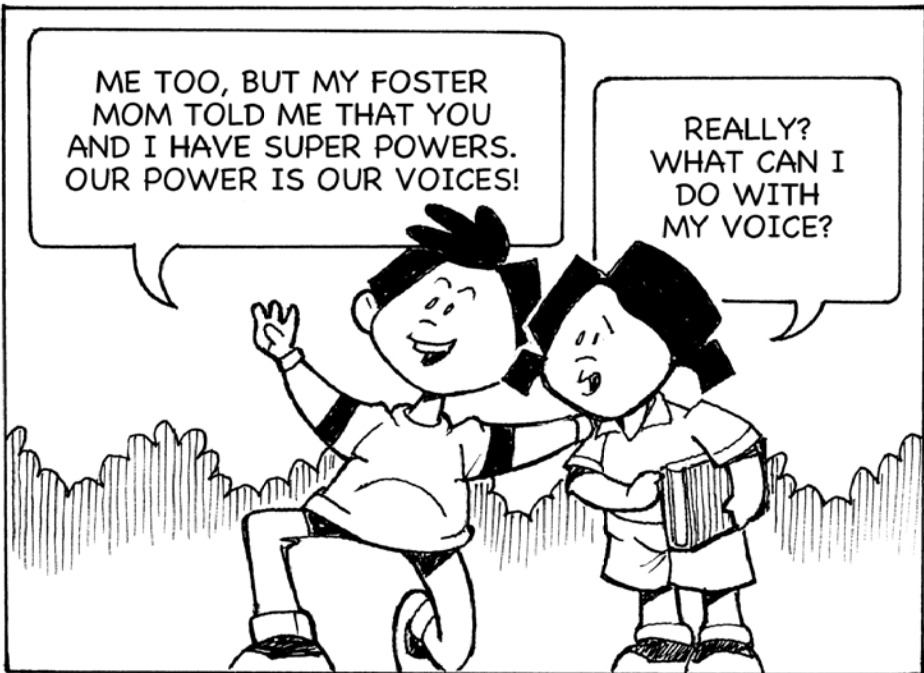
YOUR SUPER POWER IS YOUR VOICE!

ABOUT THE SAME. I WISH MOM WAS BETTER AND WE COULD MOVE BACK HOME.

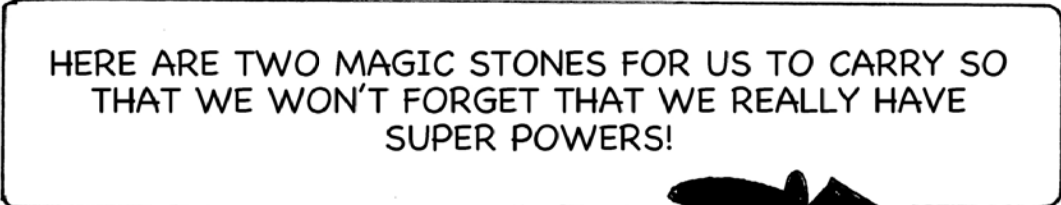

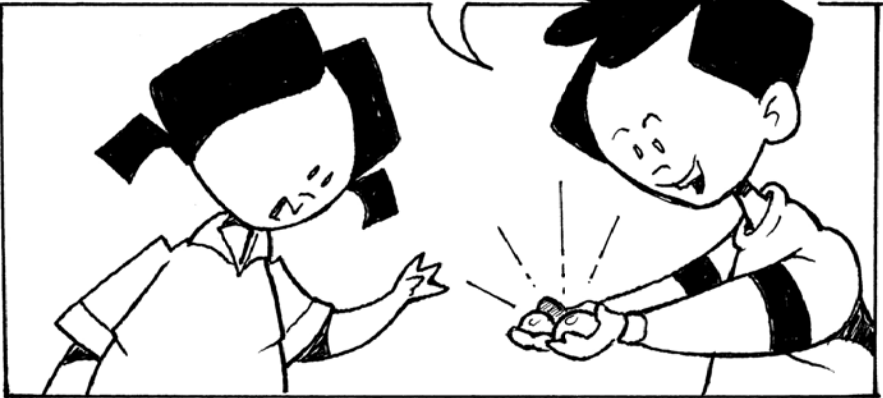
REALLY? WHAT CAN I DO WITH MY VOICE?

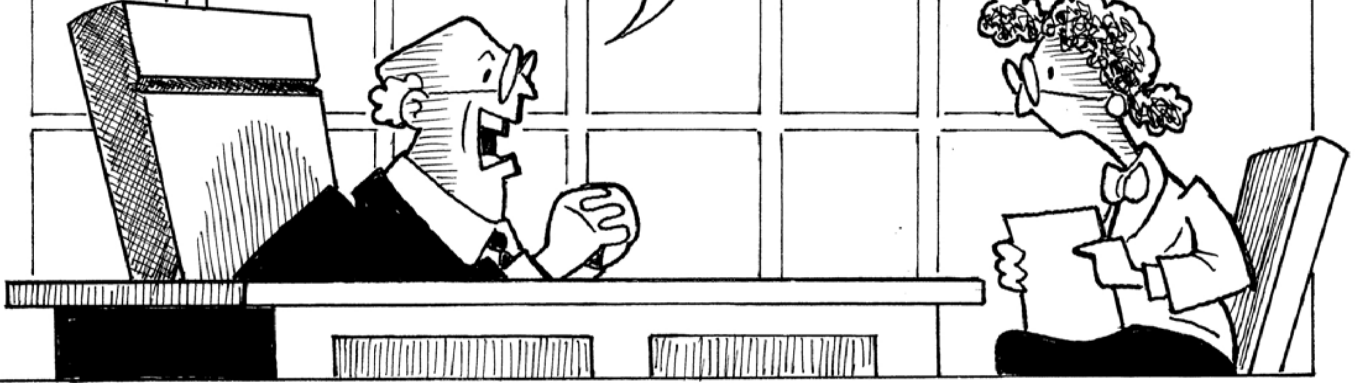

EMMA, WE'RE SO GLAD THAT YOU COULD FINALLY MOVE IN WITH US.

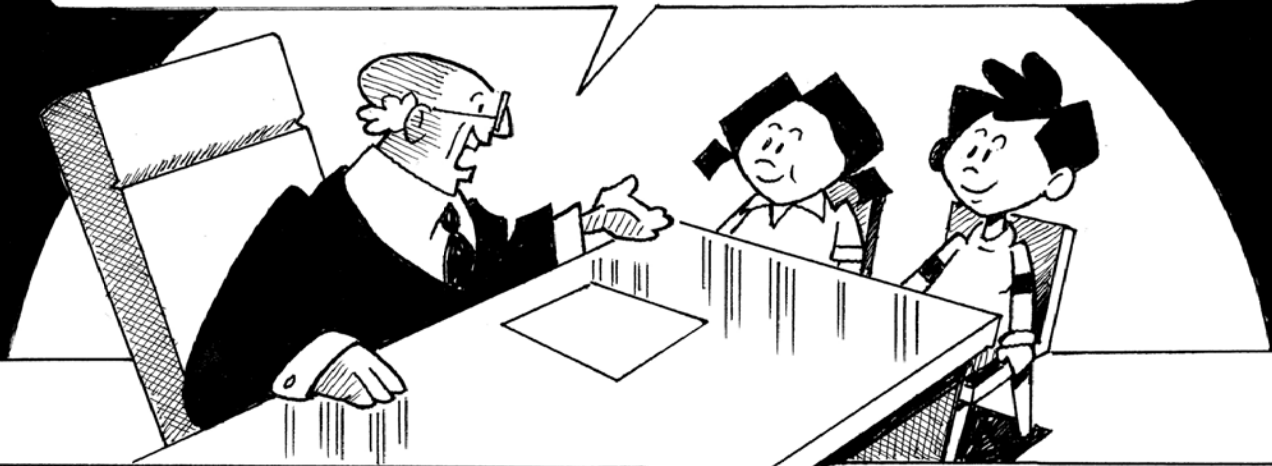

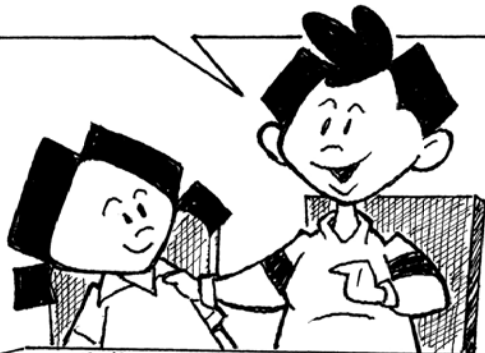

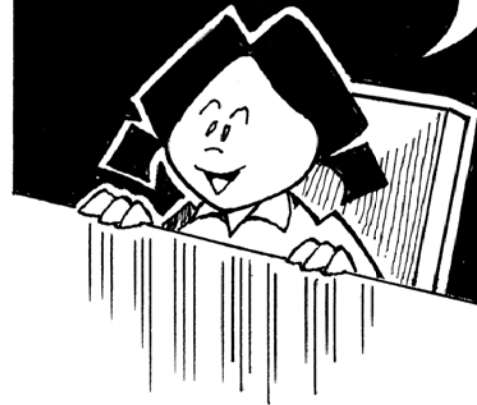
THANK YOU FOR BEING HERE TODAY, EMMA AND BEN.
IS THERE ANYTHING YOU WOULD LIKE TO SHARE WITH ME?



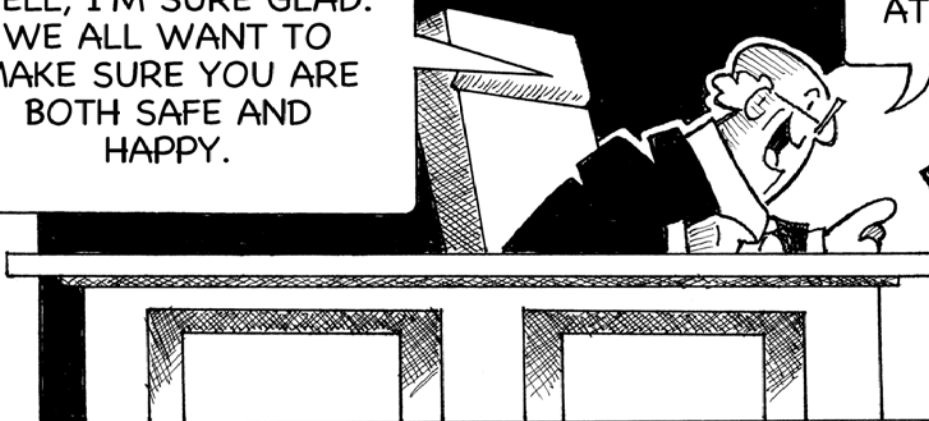
