Stat. § 25-824 (Reissue 2016) is made prior to the judgment, the judgment will not become final and appealable until the court has ruled upon that motion. See Clason v. LOL Investments, 308 Neb. 904, 957 N.W.2d 877 (2021) (citing Salikin v. Jacobsen, 263 Neb. 521, 641 N.W.2d 356 (2002)).
