

On November 10, 2021, the Nebraska Supreme Court adopted the following rule amendments to Neb. Ct. R. § 1-203 and approved the new “Court Reporting Personnel Per-Page Fee Schedule,” both with a delayed effective date of January 1, 2022:

CHAPTER 1: ADMINISTRATIVE OPERATIONS

....

Article 2: Court Reporting Personnel.

....

§ 1-203. Duties of court reporting personnel.

....

(B) Upon request of counsel or any party to a suit, furnish to such counsel or party, as expeditiously as possible, a transcription of any trial or proceedings, or any portion thereof. An official court reporter or privately contracted court transcriber shall receive the compensation specified below in § 1-218 for any such transcription, ~~except that when expedited, daily, or real-time delivery is requested for a transcription, the official court reporter or privately contracted court transcriber and the requesting party may mutually agree to an amount to be paid for delivery of such transcription.~~ Counsel or any party shall make satisfactory arrangements with the official court reporter or privately contracted court transcriber for payment. The time spent at such transcription shall not interfere with any other duties of the court reporting personnel.
