

## NOTICE OF COMMENT PERIOD

Proposed amendments to chapter 6, article 14, appendix 6, of the Nebraska Supreme Court Rules were submitted to the Nebraska Supreme Court by the Administrative Office of the Courts and Probation. Before consideration, the Nebraska Supreme Court directed that the proposed amendments be published for a period of public comment.

The Nebraska Supreme Court invites interested persons to comment on the proposed amendments. Anyone desiring to comment on the proposed amendments should do so in writing to the office of the Clerk of the Supreme Court and Court of Appeals, P.O. **REQUEST FORM FOR A COPY OF DIGITAL AUDIO RECORD  
(COUNTY COURT ONLY)**

This form is used to request a copy of the digital audio record of a A county court proceeding that has been captured through the use of an electronic recording device can be, upon request, copied onto a digital form. This form must be completed in its entirety.

If you want to request a digital audio record for a different case (unique case number), then you must complete a separate form for each case.

All case information requested can be found in the county court case file.

Send the completed form to the county court where the court hearing was held.

There will be a \$5 fee for *each* court hearing requested if the audio file is directly emailed to you. If you want the audio file downloaded onto a digital storage device, then there will be an additional \$5 fee for each additional storage device. The digital storage device will be provided by the county court.

The cost of the digital copy is \$10 for the first hearing. There is an additional charge of \$5 for each additional hearing copied onto the same digital form and a charge of \$5 for each additional digital form required.

This form is used for the purpose of requesting a copy of a digitally recorded county court proceeding. This form must be completed entirely in order for the county court staff to process your request timely. All the information requested below can be found in the county court case file. All arrangements for a digital copy are made directly with the county court staff at the court where the hearing was held.
