#### COMPLEX ISSUES IN JUVENILE COURT PRACTICE XIII

Now in its 13th year, this seminar addresses more advanced areas of juvenile court practice. This year, we are honored to offer presentations by several judges, including two from the Nebraska Court of Appeals, who will present strategies for how to improve the prosecution of appeals.

Achieving timely permanency is a critical issue in child welfare cases. This year's seminar features two panels that will address this issue, one from the bench and one from the bar. The panel of juvenile court judges will discuss barriers to permanency for children from the perspective of the bench. The second is a panel of highly-experienced child welfare attorneys who will discuss strategies for removing barriers to permanency.

There is as much need for zealous representation juveniles involved in delinquency and status-offense cases, as there is in abuse-neglect cases. A panel of experienced attorneys will offer their insights on the ethical duties surrounding the representation of juveniles involved in delinquency and status-offense cases.

This year's seminar also includes a presentation from the "Educational Rights Counsel," an organization whose goal is to generate systemic change in Nebraska by equalizing access to advocacy and legal representation for under-resourced families with a focus on special education support and student discipline.

This seminar is co-sponsored by Creighton University School of Law and the Guardian ad Litem Project, Inc., a Nebraska non-profit corporation. Lunch will be provided to those attending in person.

### **Judges**

Hon. Vernon C.R. Daniels, a University of Nebraska College of Law graduate, has served as a judge of the Separate Juvenile Court of Douglas County, Nebraska, for 10 years. He is a member of the Nebraska Supreme Court Commission on Children in the Courts as well as the Governor's Children's Task Force. He has served on the Supreme Court-Nebraska State Bar Association's Minority and Justice Task Force and now serves on the Implementation Committee of that Task Force. Judge Daniels is also a member of the steering committee of the "Building Bright Futures" initiative. He was a member of the Commission on Juvenile Diversion, Detention, and Probation Uniform Standards, as well as a board member for the Boy Scouts Diversion Program. He also co-chairs the Juvenile Detention Alternatives Initiative for the Annie E. Casey Foundation for Douglas County. Judge Daniels enjoys mentoring new attorneys and law students.

**Hon. Anne Paine** holds a degree in English Education from Kearney State College in 1984, and her juris doctorate from the University of Nebraska College of Law in 1988. She practiced law from 1988-2007after she became a County Judge in the Eleventh Judicial District, based out of McCook.
