## Parenting Time, Mediation, & You



#### Parenting Time, Custody, & Child Support

Even if you have been ordered by a court to pay or receive child support, you may not have parenting time, or custody rights established. This must be done by a separate court order. Mediation can help you and the other parent write a parenting plan to establish parenting time and custody with the courts for your child or children.

#### How Does Mediation Work?

- Mediators will meet with each parent privately at least once prior to starting mediation. Mediation may be held jointly or separately depending on what the mediator feels best meets the needs of each family.
- Mediators will ask questions to help parents identify the key issues that need to be discussed and agreed upon.
- Both parents will have the opportunity to share their view of the situation. Open and honest discussion is encouraged, including bringing your emotions to the table.
- Mediators help parents discover win/win solutions whenever possible.
- The mediator will put the agreement reached into a written parenting plan, parents then submit this document to the court.

### What if I Cannot Afford Court Fees?

#### Why Make a Parenting Plan?

Parenting plans include details on what parenting functions are to be expected from each parent at given times to make sure all needs of the children are met. Each parent brings their own unique benefits to their children, and in designing their parenting plan themselves, parents can design the best possible parenting plan for their child(ren).

#### What Does a Parenting Plan Include?

- Who has "Legal Custody" or decision making rights for the child(ren)? Parents will decide if one parent should make decisions alone or how both parents will make decisions together.
- Who has "Physical Custody" of the child(ren)? This can be sole or joint physical custody and is separate from legal custody.
- Parenting time schedule. Even if one parent has sole physical custody, a plan will need to be established for when the other parent will have parenting time.
- Holiday and vacation parenting time schedule. To make sure that children spend time with each parent for special occasions.
- Extra-curricular activities. Decisions such as who pays for extra-curricular activities, sharing activity schedules and if and when both parents will attend the children's activities.
- Communication. Details of when and how the parents will communicate with each other regarding the children with day to day issues or in the event of an emergency.
- Transportation/Transition. This will ensure both parents know who is responsible for transporting the child(ren) when they transition from parent to parent. Any special accommodations that might ensure a smoother transition for children can also be addressed in the parenting plan, such as bringing a favorite blanket or stuffed animal.
- Other appropriate issues that parents agree to include in the parenting plan.
