Motion Appellee for Summary Affirmance

Motion of Appellee for summary affirmance sustained. See Neb. Ct. R. App. P. § 2-107(B)(2). None of Appellant's allegations present circumstances involving a constitutional right where no forum is provided under Nebraska law to assert the challenge. See State v. Smith, 288 Neb. 797, 851 N.W.2d 665 (2014) (common law procedure to vacate criminal conviction limited to very rare circumstance where due process principles require forum for vindication of a constitutional right and no other forum is provided by Nebraska law). Speedy trial claim was waived by Appellant's plea. See State v. Manjikian, 303 Neb. 100, 927 N.W.2d 60 (2019) (voluntary entry of guilty or no contest plea waives every defense to a charge, whether the defense is procedural, statutory, or constitutional with exceptions including the defenses of insufficiency of the indictment, information, or complaint; ineffective assistance of counsel; and lack of jurisdiction).
